# Five outstanding Trinbago women astound Canada



ive outstanding T&T-born women were recently honoured in book form, in Canada. The five–Joan Pierre, Noreen
Callender, Gloria Small, Wendy
Jones, Nicole Waldron–have
been featured in 100 Accomplished Black Canadian Women, a bi- annual compendium of accomplished Black Canadian women across Canada. Each woman was honoured for 25-plus years of outstanding contribution to Canadian society in their respective fields.

The founders of the concept, former Canadian parliamentarian Dr Jean Augustine, Ryerson University Equity and Community Inclusion VP Dr Denise O'Neil Green and Simmonds Corporate Diversity executive Duana Iones, honoured the women at a gala event where they were introduced and celebrated.

The goal of this informative and educational publication is to highlight, document, acknowledge, and support the accomplishments of Black Canadian women in terms of their social, educational, political, and professional accomplishments.

This project grew out of a series of

discussions among the authors over a six-month period where it was concluded that this type of publication would inspire black girls and women by showcasing examples of the many contributions Black women have and continue to make in the Canadian society.

Above all, it would make it possible for black Canadian women to realise an opportunity that had not previously existed. In addition, it would help build a database for future publications that would acknowledge black Canadian women from all walks of life, and specifically, not limited to government, but would include not-for-profit, financial, legal, real estate, health, education/academic, entertainment, fine arts, unsung heroes, trailblazers, firsts, and posthumous heroes.

Accomplished women were identified through a nomination process. Women were nominated by other individuals or self-nominated by completing a nomination form. (Reporting by Peter Ray

said: "First, as a Caribbean woman and mother, I
would say that raising a well-rounded daughter in this
challenging Canadian social environment would count
as one of my most satisfying accomplishments."
"I would not count the world left in the mid-aightic

"I would next count the work I did in the mid-eighties and early inleties, laying the groundwork for moving Caribana to a full-time operation, as being critical to the growth and survival of the festival. "Finally, the contribution I make by mentoring youth

from our community and the society at large, who seek me out regularly as an elder and leader, for career advice. This is definitely a great accomplishment." A mother and trendsetter in Canada, Pierre is

a crucible of wisdom and has advise for the next generation. She said: "The key to a fulfilling life is finding the thing you are passionate about, and working to build a career around that passion. This can be a challenge, but is well worth the investment in time and patience." If Pierre had to live her life over again, she revealed: "Growing up as a woman in the Caribbean in my day, a

post-secondary education was not a priority for females, and I did not make it one of mine. I would definitely pursue a more extensive post-secondary education."



Wendy Jones is regarded as the quintessential ambassador of the steel pan. She has received numerous awards for her exceptional skills as a pan. She has received numerous awards for her exceptional skills as a pannist and her work in pan is being recognised internationally. For the past 25 years, she has worked for the Toronto Catholic District School Board as a Counselor in the Elementary and Secondary Schools and also works as an Event facilitator at Tropicana Community Services.

Born in T&T, Jones migrated to Canada at an early age as her mother decided to migrate to seek a better life and education for her children. She was introduced to pan music in 1976, while she was enrolled at Westview Certennial Secondary School.

Jones' pan journey really started in 1977 with the Afro Pan Steel band. She carries the title "Queen of the Bass" and is the recipient of numerous

Topping the list of her outstanding achievements, Jones listed "raising two beautiful children and giving my heart to God at a young age and never turning back. "In 2015, I was recognised by T&T for promoting steel pan and steel pan festivals in Canada.

"Whatever you desire out of life, try to pursue it until you have achieved your goals. Never wait on others to fulfill your dreams. Strive to do your best and always believe in yourself even if you fail to get up and keep going. Use each experience as a learning lesson to do better the next time."

Gloria Small works in the area of Mental Health, a vocation she began in T&T, before she migrated to Canada. Motivated, she has become an ardent advocate for improvements to the mental health systems in Canada and Trinidad for over 38 years. Small strongly believes

that access to a quality education that is free from discrimination and bias, is a fundamental right of all children: black children are no exception. She was also recognised by the High Commissioner for the Republic of T&T for her outstanding advocacy and philanthropic work as a member of the Trinbagonian diaspora in Canada.

"Being the mother of three beautiful, strong and independent young Black women tops my list of greatest accomplishments, said this dedicated health worker. I have also had the privilege of adopting seven wonderful children. Motherhood has given me much joy and afforded me the blessing and privilege to shape young minds and positively influence the lives of ten amazing young adults.

"Growing up to be successful and positive role models to other youth in the community, give them the understanding of the importance of giving back. I am proud of each and every one of my children."

Reflecting on her life, Small said: "I have no regrets and have had a blessed life. I would however, like to see more progress and fundamental changes to the child welfare and education systems that would result in better outcomes for African Canadian children.

"Poverty should no longer be a convenient excuse to deny children and youth their basic human right to an education and the love, safety and security that comes from family."
